Tax Relief for Low Income Seniors and Persons with Disabilities

If you receive the Guaranteed Income Supplement (GIS) or a payment under the Ontario Disability Support Program Act (ODSP), you may be eligible for tax relief equal to the amount your property taxes increased between 2023 and 2024, to a maximum of \$200. For full details, visit:

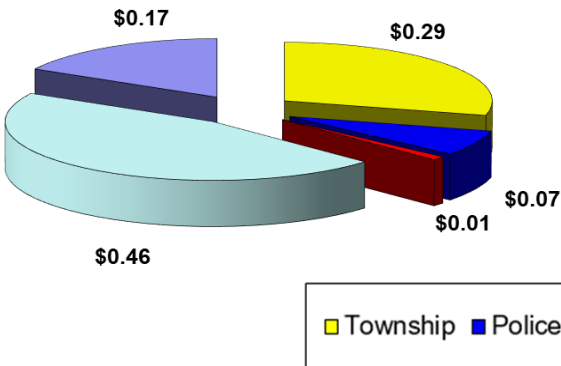

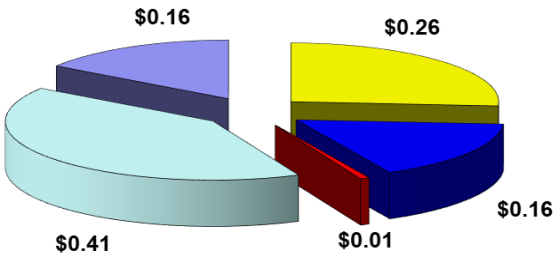

Online Tax Tools

- Pay invoices and animal licences
- View transaction and assessment history for your property tax account

Payment Information

Property taxes can be paid by:

- Pre-authorized payment
- Online/telephone banking
- Cash, debit and cheque (including post-dated)
- Credit card through PaySimply

Payments are due by the installment due dates, after that date and the beginning of each following month, penalty/interest is applied at a rate of 1.25% per month.

Reminder letters are sent after each due date.
