The application seeks relief from the provisions of Zoning By-law No. 2009-021, as amended, to permit a 12.94 m<sup>2</sup> (140 ft<sup>2</sup>) deck extension, as follows:

 With reference to Section 3.15 – Highwater Mark Setback Provisions – to reduce the minimum highwater mark setback from 30 metres to ±19 metres to an open deck.




